
## PASSENGERS ARE CONFUSED AND FRUSTRATED!

How do I book a trip cross-border in the EU?

Why do I see different prices on different websites? How do I get to the cheapest one?

What happens if my train to the airport is delayed?

*Is there any bus connection in the airport or station of my arrival or should I take a taxi?* 



They might take the easiest solution.

But... Sometimes that's not the most sustainable!

#### DEFINING AN INTERNATIONAL RAIL PASSENGER HUB

**EPF** AS 'SPONSOR' OF THE **UNECE** WORK ON THE IDENTIFICATION OF HUBS

➤ "AN INTERNATIONAL RAILWAY PASSENGER HUB IS A RAIL STATION THAT PROVIDES PASSENGERS CONNECTIONS TO MULTIPLE INTERNATIONAL AND NATIONAL RAIL SERVICES, TO OTHER HUBS AND TO THE SERVICES DELIVERED BY OTHER MODES. INTERNATIONAL RAILWAY PASSENGER HUBS CAN BE "PRIMARY" OR "SECONDARY" AS DEFINED BY MEMBER STATES AND DEPENDING ON THE LEVEL OF SERVICE OFFERED."

DEMAND + SUPPLY SIDE DRIVERS

CHECK SUGGESTED THRESHOLDS AGAINST THE ACTUAL NUMBERS (PASSENGERS AND TRAINS) CURRENTLY USING STATIONS THAT, INTUITIVELY, SEEM TO BE INTERNATIONAL HUBS

ADOPT A FUTURE-PROOF PERSPECTIVE: THINK ALSO IN TERMS OF POTENTIAL

#### CONNECTIVITY AND ACCESSIBILITY TO PASSENGERS

CONNECTION TO LOCAL PUBLIC TRANSPORT

► TAXI

► PRIVATE TRANSPORT PARKING

► AIRPORT-PORT CONNECTIONS

➢ THE HUB IS USUALLY NOT THE FINAL DESTINATION — CONNECTION TO OTHER MODES OF TRANSPORT

► NOT ONLY RAIL-RAIL, BUT CROSS-MODAL TRANSFERS, INCLUDING AIR

► WAITING AREAS **TOILETS** ► TICKETING **NFORMATION PRM** ASSISTANCE ► WIRELESS CONNECTIVITY SAFETY AND SECURITY ► CUSTOMS, PASSPORT AND BORDER CONTROLS ► PREMIUM SERVICES **COMMERCIAL SERVICES**
